KNOWLEDGE-BASED ECONOMY LAW

Promoted activities

Computer software and services; Audiovisual production; Biotechnology; Geological services; Professional export services included; Nanotechnology; Aerospace industry; Industries 4.0; Research and development.

1 Income Tax

 Reduction of the tax to: 60% micro and small businesses; 40% medium and 20% large companies.

Withholdings and earnings

- VAT exclusion in exporting companies.
- Export duties 0%.

3) Reduction of labor costs

 Tax bonus of up to 80% of contributions.

(4) Stability

 Stability of benefits for the term of its validity.

Eligibility

At least 70% of the annual turnover of the company must be generated in some activity.

Additionally

Meet at least 2 of the following requirements:

- Make improvements in the quality of its services, products and / or processes.
- Prove investment in R&D or training of employees.
- Export 4%, 10% or 13% of turnover depending on whether it is micro, small or large company.



TECHNOLOGICAL DISTRICT

To access the benefit, foreign or national capital companies are contemplated, which are located within the polygon defined as Technological District of the sectors:

- Software and IT Services.
- Hardware Production.
- Biotechnology services.
- Technology outsourcing services.
- Robotics and domotics.
- Nanotechnology services.
- 3D printing services.
- Accelerators, incubators.

Benefits:

- Exemption or deferral in Gross Income Tax.
- Stamp tax exemption.
- Exemption from payment of Real Estate Tax and ABL.
- Exemption from payment of Delineation and Construction Rights, and related taxes.
- Preferential credit lines with Banco Ciudad de Buenos Aires for the purchase of real estate and constructions.
- Programs for students attending educational institutions located in the DT.
- Educational and research programs with universities in the district.



MODERN BIOTECHNOLOGY PROMOTION REGIME

Presenting modern biotechnology projects with technological impact for:

- Research and development.
- Production of goods and/or services, or process and/or product improvements.

BENEFITS

- → Accelerated amortization of income tax.
- → **Early VAT refund** on capital goods acquired specific to the Project.

The benefit applies to the purchase of capital goods, equipment or components for the project acquired after January 1, 2020. Also included in the benefits are the expenses for services for the start-up of the goods.

PRIORITIZED PROJECTS

- → Have a local socioeconomic impact.
- →Contribute to the diversification of the productive matrix.
- → Have export potential.
- →Incorporate highly qualified personnel and include a gender perspective.
- →Produce innovations that help mitigate the effects of the COVID-19 pandemic.
